

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

By following these simple instructions, you can root hundreds of different plant varieties including African Violet, Carnation, Coleus, Fuschia, Philodendron and Rose.

1. Prepare the rooting media.
2. Snip a cutting from the plant and slightly moisten. Shake off excess moisture.
3. Dip the bottom inch of the cutting into the powder. Shake off the excess powder by tapping the cutting.
4. Plant the cutting in the prepared soil, being careful not to rub off the powder.
5. Keep the planted cutting moist while rooting. You will have new plants within a few weeks, depending upon the variety.

(DO NOT USE ON FOOD CROPS OR FRUIT TREES.)
